Surplus School Site in St. Olga Park Listed for Sale

The City of Edmonton has announced the sale of the surplus school site located at St. Olga Park at 14945 88A Street NW. The site is on the same parcel of land as St. Phillip School and Cardinal Leger Catholic Junior

Evansdale Community League has maintained long-standing interest and engagement in how the disposal of surplus school sites progresses and what happens to the sites.

St. Olga Park: What Evansdale Would Like to See

Evansdale Community League and our residents deserve a say in what happens to this site since it has the potential to affect the evolution of our community that we have all helped build over the last 60 years.

· We would like to be consulted about any proposed development of these lands by the City and the purchaser before it goes ahead

• We would have preferred the community be consulted before the land was put up for sale again, but we now will specifically request a public meeting and engagement process on the development of the site and appropriate uses of the site

. We would like to know if there are any other surplus school sites in Evansdale

• We would like to know what process is planned for the development of the site and what opportunities there are for engagement

· We believe there should be an authentic com-

munity engagement process to not only provide input into any development, but also to ensure the community and the new development move forward under a shared vision for our community.

Evansdale has a long history of engagement in the development of the neighbourhoods of Eaux Claires, Belle Rive and Evansdale. We take care to avoid knee jerk NIMBY reactions to projects, but we are also quite insistent that we and our community has an authentic role in how our community evolves.



Evansdale's Prior Engagement on the Future of the St. Olga Site Continued from page 1

The City has approached Evansdale Community League with a number of proposals for this land over the years beginning in 2016.

Prior to these dates we had numerous discussions with the city about what an appropriate development might be for these lands. We talked about seniors housing, affordable market housing, and several other possibilities. These were purely theoretical at the time.

On September 19th, 2016 we met with our city Councillor, and two representatives from the City of Edmonton about a proposal by the Muslim Association of Canada (MAC) to build a school on the site. Signs were even erected at the northeast corner of the park.

We met with representatives of MAC and asked questions about whether the Edmonton Public School board was consulted and what the impact of a new school might have on existing schools and a host of other questions. Evansdale already has three schools in the neighbourhood and two more on the border – a blessing of the highest density of schools you will find anywhere.

We asked about the impact a new school might have on Evansdale Elementary School (just down the road) and whether a new school might canabalize attendance at existing schools creating a new problem. We asked these and many other questions which were mostly left unanswered. The Muslim Association was very easy to have discussions with, but the project fell through before it got very far.

In 2018 we met with members of the Canadian Arab Friendship Association about the site. They were considering developing a cultural center there where they would host English as a Second Language courses, citizenship programs, and life skills programs. They also were considering locating offices there and meeting rooms and possibly a cultural museum. These discussions went well and the association was clearly interested in working with the community. The community league neither endorsed or rejected this proposal and it never went any further.

Then just a few weeks ago our current councillor advised us the site was going up for sale to unknown potential buyers the next day after we were advised. .

The listing on the City website says this is "A rare opportunity to develop a 3.05 acre surplus school site in the mature neighbourhood of Evansdale! While currently zoned Urban Services (US), this site has potential for a future multifamily or community development."

It is a little surprising we were not consulted or advised, given our long history of expressing interest and how active we have been in playing a role in the disposal of school sites.

services. Another is to offer meaningful opportunities for input into decision making at the Board level. To that end, ECSD, on behalf of the Board, conducted a Community of School Councils (COSC) engagement session to gather feedback from our School Councils about the ECSD Board Advocacy Plan, as well as the best ways to share their voice in future engagements and through Division surveys.

School council representatives identified the following three advocacy themes as being the most important for their schools: Serving our Learners with Exceptional Needs, Serving Our Youngest Learners - Pandemic Recovery, and Curriculum-New Curriculum. Following are the top three themes that were suggested for the Board to consider: focusing on mental health support; providing pandemic supports: and focusing on literacy. The Board valued the opportunity to meet with and gather the insights and feedback of our school councils. The information collected will be used to inform the Board's advocacy efforts with government. With the announcement

that all K-3 students will learn new Mathematics and English Language Arts and Literature curriculums, while all K-6 students will learn from new Physical Education and Wellness curriculum beginning in the 2022-2023 school and the subsequent release of the materials, our Learning Services staff have begun planning for the necessary professional learning and logistics to ensure that our schools are ready to provide excellent educational experiences for our students in these areas.

As we continue to focus on student success, I welcome the opportunity to engage with our school communities as I am committed to making decisions that are in the best interests of our Division and ensuring the well-being of our students is at the forefront of all that we do! Sponsored article

Ask Charles – Real Estate Advice

I'm selling my house, but I'm concerned about having strangers in my home during the CO-VID-19 pandemic. How can I minimize my risk? Based on your concerns, you and your real estate professional can find options to minimize

your risk and ease your mind, including: Screening potential viewers for symptoms of COVID-19. You do not have to allow anyone into your residence if you feel that an individual may pose a risk to you. Your real estate professional can help draft questions to ask buyers, tenants, and their representatives about their health and travel information.

getting acknowledgement of viewing conditions in writing. Work with your real estate professional to develop a list of conditions for viewings such as using gloves, masks or hand sanitizer, or limiting the number of people at any time or during a specific time period. Keep in mind that viewing terms are subject to negotiation between parties. Have your real estate professional put them in writing and require the buyers and their professionals to sign off on the agreed-upon terms. Please always bear in mind, if you make the viewing conditions too strict, the potential buyers have the option to simply go looking for something else.

• communicating viewing conditions to property measurement companies, virtual tour companies, and home inspectors. Some appraisals can also be done through virtual tours.

• taking extra precautions to clean and sanitize your home before and after any viewings or inspections. Discuss with your real estate professional who will be responsible for cleaning and sanitizing high-touch areas of your home before and after.
